**NOTE:** Number of equipment provider blocks and order may change at any time. It is important that your program read the number of blocks included and use the information in each block. Data for a particular equipment provider may not always be in the same position.

## Do not assume:

- 1. Number of equipment providers will not change.
- 2. Order of equipment providers blocks will not change.

Full file will be produced daily with update files produced every hour. If there are no updates within the hour, a file will still be produced which will contain 1 record with text "NO UPDATES" in it.



## **EDI TRANSMISSIONS TO INTERMODAL FACILITIES**

IANA has developed a standard format for transmission of information pertaining to a Motor Carrier's equipment interchange status with specific Equipment Providers, for use by Intermodal Facility Operators. Data fields include:

- UIIA Trucker ID
- Standard Carrier Alpha Code (SCAC)
- Motor Carrier Company Name, Address, Phone and Fax
- Insurance Expiration Dates for General Liability, Auto Liability, Cargo and Trailer Interchange policies
- Known As Code this is the code that is utilized to identify the Motor Carrier by the Equipment Providers that are not utilizing the SCAC Code as the identifier.
- Valid String for specific Equipment Providers a Yes/No string that indicates whether the Motor Carrier is valid for a specific Equipment Provider

All EDI transmissions are in Flat Ascii file, fixed column format and provided via SFTP Pull.
